The Ballarat Rovers M.C.C. will conduct a club Pony Express on **Sunday September 7th 2008 at Avoca (370 Lamplough Green Hill Creek rd Amphitheatre)** and is open to financial members of the B.R.M.C.C only.

JURISDICTION: The Pony Express will be held under the jurisdiction of the 2008 GCR's of MA with the following Supplementary Regulations and any instructions issued on the day.

CLASSES: Junior Up to 100cc 2st / 150cc 4st, Junior Up to 125cc 2st / 250cc 4st, Father & Son (1½ Hrs Duration) Novice, Clubman, Expert, Veterans (over 35yo) and Ironman (All 3 Hrs Duration)

Please note riders may only enter ONE class in teams of two on one or two bikes. (Except Ironman)

AWARDS: Will be BRMCC trophy awards to 3rd place all classes.

ENTRIES: \$35- Per rider (Senior Classes), \$25- per rider (Father & Son, Junior classes), (includes \$10 MA rider levy)

Entries close Thursday August 28th 2008.

ABSOLUTELY NO LATE ENTRIES WILL BE ACCEPTED.

The club reserves the right to limit classes should an excess number of entries be received. First in first served.

LICENCE: All riders must hold a current M.A. competition licence. 1 Day licenses will be available from the club with your Entry at a cost of \$45-. **If a 1-day licence is required please indicate on entry, include money and provide Ambulance subscription number. (Please note that a 1 Day Licence cannot be issued without proof of Ambulance Membership)**

NOISE: This year there will be zero tolerance of noisy machines (less than 96 dba) as noise is the biggest problem facing the future of our sport and its ongoing viability. **NOISY BIKES DO NOT EQUATE TO FAST BIKES !!!!!**

STARTING TIME: Sign in 8.30 am. Competitors are to sign in then present bikes and helmets at scrutineering. All riders must attend riders briefing prior to sighting lap, approx 9.30am for juniors & Father/Son. Approx 11.30pm for all other competitors. No riding before sighting lap. Start 10.00am. Juniors & Father/Son. All other classes will start at 12.00pm. Start will be a Le Mans start.

CONTRACT TO PARTICIPATE IN MOTOR CYCLE SPORTING EVENT AND/OR ACTIVITY

HEREBY AGREE with the persons, organisations and bodies corporate whose name appear in Schedule 1 (hereinafter collectively called "The Organiser" that I am by this agreement entitled to participate in the motorcycle activity/meeting listed in Schedule 2 (hereinafter called "The Meeting" at the venue listed at Schedule 3 (hereinafter called "The Venue" on the terms and conditions set out in this document.

ACKNOWLEDGEMENT OF RISKS, DANGERS AND OBLIGATIONS

I ACKNOWLEDGE that motorcycle sport is dangerous and that by engaging in the sport and participating in the meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:

- a) that I may be injured, physically or mentally, and may be killed;
- b) that my machinery or equipment may be damaged, lost or destroyed;
- c) that the other competitors may ride dangerously or with lack of skill;
- d) that track or event conditions may be hazardous and may vary without warning or predictability;
- e) that organisers, officials, landowners, track operators and any agent or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time and / or events;
- f) that any policy of insurance of or in respect of my life or physical or mental health may be voided;
- g) that there may be no or inadequate facilities for treatment or transport of me if I am injured;
- h) that I have an obligation to myself and to others to compete safely and within the rules of the competition.

INDEMNITY GIVEN TO ORGANISERS

IN CONSIDERATION of the acceptance of me as an entrant in the meeting **I AGREE TO INDEMNIFY** the organisers and each of them in the following manner:

- a) that I participate in the meeting at my sole risk and responsibility;
- b) that I accept the venue as it stands with all or any defects hidden or exposed;
- c) that I indemnify and hold harmless the organisers, their respective servants, agents or officials against any actions or claims which may be made by me or on my behalf or by other parties for or in respect of or arising out of my death or injury loss or damage caused to me or to my machinery or equipment whether caused by negligence, breach of contract or in any other manner whatsoever.
